



June 2019 Working together for a just culture **Recommendation 11:** Those providing expert witness reports and evidence should be required:

- To state in a specific section of their report the basis on which they are competent to provide an expert opinion on the matters contained within the report or evidence.
- To state in a specific section of the report where their views fit on the spectrum of possible expert opinion within their specialty.
- To calibrate their reports to indicate whether an individual's conduct was, in all the
 circumstances, within the standards that could reasonably have been expected, below
 the standard expected; far below the standard expected; or whether the individual's
 conduct was truly, exceptionally bad. They should also give their reasons for the views
 reached.

Recommendation 12: Doctors should only provide expert opinion to the coroner, procurators fiscal, police, CPS, GMC or to the criminal court on matters which occurred while they were in active and relevant clinical practice.


Why are we launching this now?

The Case: that the surgery was carried out negligently and that post op care was negligent



I was the Defendant, not just an expert in a Civil Case

- Trial took 8 days
- Hospital and NM co defendants with separate teams of lawyers and barristers and experts, three teams in all
- NM in dock for 1.5 days
- 5 other medics and one nurse from the JR witnesses



What is an Expert Witness?



- Neither an expert on the law nor a witness because not there in real time
- Asked to give an expert opinion on the medical details of the case
- Quite different from a factual or professional witness



If you were the plaintiff or patient what sort of an expert would you want?

- Someone who had done it before
- They had been trained
- They were truly an expert in the subject of the case
- They were compassionate
- They had honesty and integrity



If you were the defendant what sort of an expert would you want?

- Someone who had done it before
- They had been trained
- They were truly an expert in the subject of the case
- They were compassionate
- They had honesty and integrity

Key Messages



- Expert witnesses play a vital role
- Provide independent balanced and objective views
- Was there substandard care and did this cause patient harm?



Which Court?



- Coroner's Court
- Civil Court
- Criminal Court

Experts need to understand the difference between these environments

What issues are covered?



- The role to whom is the expert evidence addressed
- Surgical expertise don't stray
- Prior experience to support your opinion
- Training

Who can be an expert?



- Consultant surgeon for at least 5 years
- Advise on cases in their routine practice and subspecialty
- Give an opinion contemporary with the events
- Discontinue after 3 years from retirement from clinical practice

Legal issues



- Instructions
- Standard of care liability
- Breach of duty
- Harm
- Causation
- Condition and prognosis

So why do it?



- We need good experts
- It will be intellectually stimulating
- It may inform your own practice
- It may help prevent similar harm to a patient in the future
- You may help a colleague in need
