

Global Surgical Advisor

Terms of Reference

1. Introduction

- 1.1 The Royal College of Surgeons of England (RCS England) is a professional membership organisation and registered charity (no. 212808). The College exists to promote excellence in the practice of surgery through its role in setting standards, providing quality assurance and supporting the training and professional development of surgeons to enable them to achieve and maintain the highest standards of surgical practice and patient care.
- 1.2 The College has a global multidisciplinary membership, supporting 30,000 members in the UK and internationally by improving their surgical skills and knowledge, facilitating research, setting standards and developing policy and guidance. Approximately 25% of its members reside outside the UK in 100 countries around the world. In addition, many members are engaged in a diverse range of international projects and collaborations, which include global surgical trials, capacity-building initiatives to strengthen surgical care systems and overseas faculty training and development.
- 1.3 RCS England is committed to strengthening the involvement and participation of its international members in its work and activities.

2. Remit

- 2.1 Global Surgical Advisors (GSAs) play an important and strategic role in representing the College within a specified overseas geographical region. They act as key points of contact for members residing in these regions and for UK-based members who have an interest in or wish to engage or collaborate internationally. Global Surgical Advisors are responsible for working with the Global Affairs Office to develop appropriate strategic relationships within their respective regions and providing the lead on the College's engagement and project collaborations with the aim of enhancing and maintaining international standards in the practice of surgery. Key aspects of the role include, but are not limited to:
 - Contributing to the development of the College's global strategy and leading on the formulation of engagement plans for their respective regions.
 - Developing and maintaining effective communications with members, including ascertaining the views and concerns of members on relevant issues and adequately representing these views on the Global Affairs Standing Committee (GASC).
 - Establishing and maintaining a network of Country Advisors within their respective regions.



- Identifying emerging issues and advising the GASC on the implications of any policies, curricula changes, practice developments, research, strategies or discussions on the direction of the College's international activities or its overseas members.
- Advising the GASC generally, including identifying any opportunities which may exist to extend the influence of the College, secure funding from external sources, strengthen or build its profile and consolidate its position.
- Promoting the College, its services, qualifications, courses, research, training programmes, examinations and standards.

3. Appointment

3.1 RCS England regions¹

A Global Surgical Advisor shall be appointed for each of the following geographical regions²:

- (a) Americas
- (b) Europe
- (c) Middle East & North Africa
- (d) South East Asia
- (e) Sub-Saharan Africa
- (f) Western Pacific

3.2 Eligibility

Global Surgical Advisors must be:

- (a) A fellow of the College in good standing or be prepared to apply for *ad eundum* Fellowship;
- (b) In good standing with their relevant national medical authority;
- (c) Up to date with their Continuing Professional Development (CPD)/ Continuing Medical Education (CME) requirements;
- (d) In current surgical practice;
- (e) Residing in the region that they will be representing (desirable, but not essential).

3.3 Procedure

- (a) The procedure for appointing a Global Surgical Advisor shall be determined and overseen by the GASC, which shall invite applications or expressions of interest from the membership in the first instance.
- (b) In determining the procedure, the GASC shall consider a number of factors, including the following:
 - The number of College members within the region.
 - The number of applications or expressions of interest received.

¹ The geographical regions are based on the regional groupings used by the World Health Organisation (WHO). WHO Member States are grouped into 6 geographical regions: AFRO (Africa), AMRO (Americas), EMRO (Eastern Mediterranean) – Middle East and North Africa, EURO (Europe), SEARO (South-East Asia) and WPRO (Western Pacific).

- The activities of the College within the region and any existing or proposed collaborations or partnerships.
- Whether the region would be best served by holding elections or establishing an interview panel.
- (c) Notwithstanding paragraphs (a) and (b) above, members applying for a Global Surgical Advisor position will need to demonstrate, amongst other things, the following skills and qualities:
 - A commitment to promoting the RCS, its services, qualifications, research, training programmes, examinations and standards within the region.
 - Knowledge and understanding of surgical education, training, practice and research in the region.
 - Well established contacts with surgeons, surgical societies and relevant health institutions within the region.
 - Involvement in or membership of networks, forums or associations within the region.
 - Ability to work as part of a team and be proactive.
 - Ability to provide leadership, set goals and inspire others.
 - An interest in developing new RCS-supported activities for surgeons and other health care professionals in the region.
 - Experience of living and/or working within the specified region (desirable).

3.4 Council approval

The appointment of Global Surgical Advisors shall be approved by RCS Council.

3.5 Term

Global Surgical Advisors shall be appointed for a term of three years. Subject to approval by Council, the term shall be renewable for a further two years.

4. Accountability and reporting

- 4.1 Once appointed, Global Surgical Advisors shall be accountable to the Global Affairs Standing Committee and will be expected to:
 - (a) Represent the RCS in their respective regions in their professional relationships and through attendance at national and/or regional meetings. Advisors will represent the RCS by describing themselves as the 'RCSEng Global Surgical Advisor for [Region]' and by promoting as appropriate RCS international activities, vision and mission.
 - (b) Actively contribute to the development and implementation of the Global Affairs Standing Committee's work programme, attending all meetings of the Committee and providing written reports.
 - (c) Provide advice in relation to their respective regions, particularly in terms of proposed projects, partnerships or collaborations.



- (d) Develop and implement an engagement plan for their respective regions, detailing for example, regional priorities and objectives; key institutions to be engaged; opportunities for developing country advisors; building the profile and presence of the RCS within the region and mapping the existence (or otherwise) of specialist training programmes and research networks.
- (e) Communicate and engage with members within their respective regions on a regular basis.
- (f) Promote and raise awareness of education, training, research and practice issues and developments within the region amongst the wider RCS membership using the RCS website, Bulletin, Newsletter and RCS events or meetings.
- (g) Submit an end of year report to the Global Affairs Standing Committee, which will be included in the Committee's annual report to Council.

5. RCS support for the Role

- 5.1 Global Surgical Advisors will be expected to work closely with the RCS Global Affairs Office as they undertake their role. In return, Advisors will receive the following support:
 - (a) Induction programme;
 - (b) Administrative and project support from the Global Affairs Office;
 - (c) Development of a network of Country Advisors within each RCS region to support the Global Surgical Advisor role;
 - (d) Access to a Global Surgical Advisor Performance Toolkit and Framework³; and
 - (e) Reasonable travel and accommodation expenses to attend one Global Affairs Standing Committee meeting in person during the RCS financial year.

6. Review

- 6.1 The position of all Global Surgical Advisors shall be reviewed annually in order to ensure that they remain relevant and effective. Key review areas shall include:
 - (a) Terms of reference for Global Surgical Advisors;
 - (b) Performance in relation to successes, achievements and impact; and
 - (c) Issues and challenges affecting a Global Surgical Advisor's ability to fulfil the requirements of the role.
